**AN ORDINANCE TO AMEND ORDINANCE NO. 87 OF CHIKAMING TOWNSHIP ENTITLED: AN ORDINANCE TO ESTABLISH COMPREHENSIVE ZONING REGULATIONS FOR THE TOWNSHIP OF CHIKAMING, PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF THE TOWNSHIP RURAL ZONING ACT, ACT 184 OF THE PUBLIC ACTS OF 1943, AS AMENDED, BY ACT 637, OF THE PUBLIC ACTS OF 1978, AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH AND TO PROVIDE PENALTIES FOR VIOLATIONS HEREOF.**

**THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:**

Section 1.


The official zoning map of Chikaming Township, as provided for by Article 3 of the Chikaming Township Zoning Ordinance, is changed and amended to provide the following described parcel of land is zoned **AG Agricultural**:

That part of the South Half of the Northeast Quarter of Section 11, Township 7 South, Range 20 West, Chikaming Township, Berrien County, Michigan described as follows: Commencing at a point on the East line of said Section that is North 00° 17' 38" East (recorded North 00° 17' 35" East) 532.65 feet from the East Quarter Post of said Section; thence North 89° 32' 42" West 371.27 feet; thence South 00° 17' 38" West (recorded South 00° 17' 35" West) parallel to said East line, 516.64 feet; thence North 89° 32' 37" West, parallel to the East and West Quarter line of said Section, 1224.09 feet; thence North 00° 13' 08" East, 666.61 feet (recorded 666.77 feet) thence South 89° 32' 42" East 1596.23 feet to said East line of said Section 11, thence South 00° 17' 38" West (recorded South 00° 17' 35" West), along said East line and the centerline of Flynn Road, 150.00 feet to the place of beginning.


The change shall be made on the Official Zoning Map within ten (10) days after the enactment of this Ordinance as provided by Section 3.01, C., of the Chikaming Township Zoning Ordinance.

Section 2.

Enactment. The foregoing change and amendment to Ordinance No. 87, the Chikaming Township Zoning Ordinance, was enacted on the 14th day of March, 2013, by the Township Board of Chikaming Township, Berrien County, Michigan, and ordered to take effect on the 1st day of April, 2013, the same being more than seven (7) days after its publication.


### CERTIFICATION
