

Ordinance # 5

AMENDMENT TO THE ORDINANCE AUTHORIZING CONSTRUCTION AND OPERATION OF A WATER SYSTEM FOR CHIKAMING TOWNSHIP, BERRIEN COUNTY, MICHIGAN, WHICH ORIGINAL ORDINANCE WAS ADOPTED MARCH 9, 1951, THIS AMENDMENT TO SUB-PARAGRAPH F. Section 8 PROVIDING PAYMENT SCHEDULE FOR DIS-CONNECTION AND RE-CONNECTION OF WATER SERVICE.

Whereas the ordinance authorizing the construction and operation of a water system for Chikaming Township, Berrien County, Michigan as originally adopted March 9, 1951, provided that rates and charges for water and for water service "shall be subject to such increase and revision from time to time as may be necessary to carry out the provisions of this ordinance";

And whereas it is deemed necessary that a revision be made in Sub-Paragraph F of Section 8 of said paragraph in order to provide a schedule of rates for dis-connection and re-connection of water service by adding to said sub-paragraph F of Section 8 of said ordinance such a schedule;

NOW THEREFORE, the Township of Chikaming ordains that sub-paragraph F of Section 8 of the aforesaid Ordinance, be amended by adding thereto the following:

Schedule of charges for disconnection and reconnecting of water service:

For all services ordered disconnected, the meter shall be removed and a charge of \$3.00 shall be made for final reading and removal of meter, and the meter deposit paid by such customer, after deducting any balance then due the Chikaming Water Department, shall be refunded to said customer.

For all water services ordered reconnected, re-connection charges for the respective meter sizes shall be as follows:

The above mentioned schedule of charges for disconnection and reconnection of service to become effective April 1, 1955.
