If the enforcing agency determines a violation's exists, it shall be corrected by the responsible installer. The permit application shall include the application fee, the number of water treatment devices recorded in the item #25 for \$5.00 each, and the appropriate water distribution pipe (system) size fee.

Instructions: General: Mechanical work shall not be started until the application permit has been filed. All installations shall be in conformance with the Mechanical Code. No work shall be concealed until it has been inspected. When ready for inspection, call the inspector, providing as much advance notice as possible. The inspector will need the job location, type of inspection, and permit number.

Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time commencing work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR RESTARTED.**
