**AN ORDINANCE TO DESIGNATE AN ENFORCING AGENCY TO DISCHARGE THE RESPONSIBILITY OF THE TOWNSHIP OF CHIKAMING UNDER THE PROVISIONS OF THE STATE CONSTRUCTION CODE ACT BEING ACT 230 OF THE PUBLIC ACTS OF 1972, AS AMENDED, PERTAINING TO MECHANICAL AND PLUMBING INSTALLATIONS WITHIN THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN.**

**THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:**

**SECTION 1**


AGENCY DESIGNATED. Pursuant to the provisions of the Michigan Mechanical Code and Michigan Plumbing Code, in accordance with Section 8b(6) of Act 230 of the Public Acts of 1972, as amended, the plumbing inspector and mechanical inspector of the Township of Chikaming, is hereby designated as the enforcing agency to discharge the responsibilities of the Township of Chikaming under Act 230 of the Public Acts of 1972, as amended, pertaining to plumbing and mechanical installations. The Township of Chikaming hereby assumes responsibility for the administration and enforcement of said Act throughout its corporate limits.

**SECTION 2**


REPEALS. All ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

**SECTION 3**

ENACTMENT AND PUBLICATION. This ordinance was enacted on the 8th day of April, 2004, by the Chikaming Township Board and ordered to be published in the SouthCounty Gazette on the 19th day April, 2004, being within thirty (30) days of its enactment and ordered to be made effective on the 24th day of May, 2004, being thirty (30) days after publication thereof.
