## TOWNSHIP OF CHIKAMING BERRIEN COUNTY, MICHIGAN

ORDINANCE NO. 140 Adopted: October 12, 2017

AN ORDINANCE TO AMEND ORDINANCE NO. 126 BEING AN ORDINANCE TO ESTABLISH RULES AND REGULATIONS TO CONTROL AND GOVERN THE USE OF PUBLIC BEACHES, ROAD END BEACHES, PARKS AND PRESERVES LOCATED IN CHIKAMING TOWNSHIP, BERRIEN COUNTY, MICHIGAN; TO PROVIDE PENALTIES FOR THE VIOLATION THEREOF, AND TO REPEAL ALL ORDINANCES IN CONFLICT HEREWITH.

## THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

Section 1. Section 15, of Ordinance No. 126, of Chikaming Township, is hereby amended to read as follows:

Section 15. From and after the effective date of this Ordinance, no person, firm or corporation shall move construction machinery or equipment in, upon or across the land, roads, bluffs, and facilities at a public park, preserve or beach without first securing a written permit therefore from Chikaming Township. An application for such a permit may be obtained during regular business hours at the Chikaming Township offices. The decision whether to issue a permit shall be made by two representatives of the Chikaming Township Park Board chosen by the Park Board, and the Supervisor pursuant to rules approved by the Chikaming Township Board. The express purpose of this provision is to safe guard and prevent the damage of any water intake pipes or other similar facilities, structures, dunes and/or beaches located in the public parks, preserves or beaches. A permit shall not be required for emergency access where public health, safety or welfare is threatened, and the Chikaming Township Police Chief, Fire Chief and Supervisor shall have the authority to open a gate under such circumstances. In addition, the Chikaming Township Police Chief and Fire Chief may open a gate without a permit to allow access for safety training purposes.

Section 2. This ordinance was enacted on the 12 day of 0 ctobus 2017, by the Township Board of Chikaming Township, Berrien County, Michigan, and ordered to take effect on the 12 day of 12 day of 12 v., 2017, the same being more than thirty (30) days after the date of publication.
