

CHIKAMING TOWNSHIP  
ORDINANCE NO. 27

AN ORDINANCE ESTABLISHING A GROUP LIFE INSURANCE PLAN FOR ALL ELECTED OFFICIALS AND ALL FULL TIME EMPLOYEES OF CHIKAMING TOWNSHIP, BERRIEN COUNTY, MICHIGAN, AND PROVIDING A METHOD OF PAYING PREMIUMS ON SAID GROUP LIFE INSURANCE PLAN.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN, ORDAINS:

SECTION I

The Township of Chikaming, Berrien County, Michigan, hereby ratifies and confirms the adoption of a contract for group life insurance for all elected officials of Chikaming Township and all full time employees of said Township as a participating employer under Michigan Township Association's Policy No. GT 8800 written by Manufacturer's Life Insurance Company and made effective April 1st, 1971 and which group life insurance contract together with all of its terms and conditions are incorporated in this ordinance as though fully set out herein.

SECTION II

All elected officials and all full time employees of Chikaming Township are to be covered by the aforesaid group life insurance plan, hereinabove described, according to the terms and conditions of said group life insurance contract.

SECTION III

All premiums on the group life insurance policy shall be paid from the general fund of Chikaming Township without contribution of any kind by the elected officials or full time employees of the Township covered by the group life insurance plan.


SECTION IV

All actions heretofore taken by the Chikaming Township Board and the Supervisor and Clerk of said Township in connection with the adoption of the aforesaid group life insurance plan and the execution of the contract for such insurance are hereby fully ratified and confirmed.


SECTION V
