AN ORDINANCE TO AMEND ORDINANCE NO. 10 ENTITLED:
CHIKAMING TOWNSHIP ZONING ORDINANCE ENACTED
MARCH 5, 1964.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, STATE OF MICHIGAN,
ORDAINS:

Article XIV of the Chikaming Township Zoning Ordinance enacted
March 5, 1964, entitled, DEFINITIONS, and more particularly under the
category entitled Zoning Districts:

Section 2 thereof is amended under Commercial Districts, Sub-Section 2,
to provide:

- (2) Beginning 330 feet East of the South 1/4 post of Sec. 2,
thence North 433 feet; thence East 330 feet to the West
line of the East 1/2 of the S. W. 1/4 of the S. E. 1/4 of
said Section 2; thence South 100 feet; thence East
approximately 975 feet to the railroad right-of-way;
thence Southwesterly along the right-of-way to the South
section line; thence West to the point of beginning.

The foregoing amendment to the Chikaming Township Zoning Ordinance
No. 10, enacted March 5, 1964, was approved by the Township Board of Chikaming
Township, Berrien County, Michigan, on the 9th day of April, 1981,
and ordered to take effect immediately.
