

ORDINANCE NO. 49  
Adopted March 15, 1984

AN ORDINANCE TO AMEND ORDINANCE NO. 44 ENTITLED: AN ORDINANCE TO ESTABLISH COMPREHENSIVE ZONING REGULATIONS FOR THE TOWNSHIP OF CHIKAMING, PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT AND AMENDMENT THEREOF, IN ACCORDANCE WITH THE PROVISIONS OF THE TOWNSHIP RURAL ZONING ACT, ACT 184 OF THE PUBLIC ACTS OF 1943, AS AMENDED, BY ACT 637, OF THE PUBLIC ACTS OF 1978, AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH AND TO PROVIDE PENALTIES FOR VIOLATIONS HEREOF.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, STATE OF MICHIGAN ORDAINS:

Section 1.

The official zoning map of Chikaming Township, as provided for by Article I of the Chikaming Township Zoning Ordinance, is changed and amended to provide that Lots 1-4 and 10-18, Hanus Subdivision, according to the recorded plat thereof, Chikaming Township, are zoned R-1 Single Family Residential. The change shall be made on the Official Zoning Map as required by the Zoning Ordinance.

Section 2.

The foregoing change and amendment to Ordinance No. 44, the Township Zoning Ordinance, adopted November 12, 1981, was approved by the Township Board of Chikaming Township, Berrien County, Michigan, on the 15th day of March, 1984, and ordered to take effect immediately.
