AN ORDINANCE TO AMEND ORDINANCE NO. 13, CHIKAMING TOWNSHIP,
ADOPTED MAY 6, 1965, AS AMENDED, AND TO AMEND ORDINANCE
NO. 40, ADOPTED NOVEMBER 19, 1979, AS AMENDED.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

SECTION I.

Section 9 of Ordinance No. 13 of Chikaming Township, as amended,
is hereby amended to read as follows:

System 9. The system shall be operated on the basis of a fiscal
year beginning on April 1st of each year and ending on March 31st of
the following year.


SECTION II.

Section 8.01 of Ordinance No. 40 of Chikaming Township, as
amended, is hereby amended to read as follows:

Section 8.01. The system shall be operated on the basis of a
fiscal year beginning on April 1st of each year and ending on
March 31st of the following year.


SECTION III.
