
AN ORDINANCE TO AMEND ORDINANCE NO. 13 OF CHIKAMING TOWNSHIP WHICH WAS ADOPTED ON MAY 6, 1965, AND TO REPEAL ALL OTHER ORDINANCES IN CONFLICT HEREWITH AND TO PROVIDE PENALTIES FOR VIOLATIONS HEREOF.

THE TOWNSHIP OF CHIKAMING, BERRIEN COUNTY, MICHIGAN ORDAINS:

Section 1. Section 10(m) of Ordinance No. 13 of Chikaming Township which was adopted on May 6, 1965, as amended, is hereby amended to read as follows:


Section 10. (m) The Township Board, through the Township Supervisor, may impose temporary restrictions on the use of the public water system when the Water Superintendent, after consultation with the Township's Engineer, determines that the demand for water may exceed the sustained delivery capability of the water system. The Water Superintendent shall make the determination in writing and submit same to the Supervisor together with recommended restrictions. The Supervisor shall take all reasonable measures to inform the system's users of the temporary restrictions including the use of public announcements through the news media. Any water system user who fails to comply with the temporary restrictions, as imposed, upon notification of same, shall be subject to the imposition of a fine not to exceed \$100.00, and the Township shall have the right to install a meter flow reducer, adjust the service valve at the meter pit or remove and seal the connection to the service line and shut off water service to any premises that fails to comply with the restrictions.

Section 2. Enactment. This ordinance was enacted on the 15th day of April, 1999, by the Chikaming Township Board and ordered to be published in the Southcounty Gazette and Shopper on the 3rd day of May, 1999, being within thirty (30) days of its enactment and ordered to be made effective on the 3rd day of June, 1999, being thirty (30) days after publication thereof.
